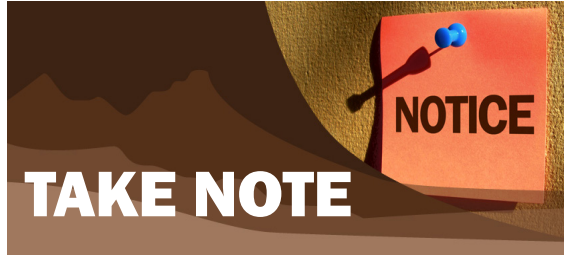

Any person who deems to be affected by the issuance of these permits may appeal to the Subdivision and Development Appeal Board by 4:30 p.m., April 7, 2022. On Permitted Uses, grounds for appeal must relate to questions of interpretation, variance, or relaxation, and not to the proposed use. On Discretionary Uses, all aspects of the proposed development may be challenged upon appeal. Written notice of appeal, accompanied by the appeal fee as established by Town Council, shall be filed through the Office of the Secretary of the Subdivision and Development Appeal Board at 101 RancheHouse Road Cochrane, Alberta T4C 2K8.

FREE INCOME TAX SERVICES ARE AVAILABLE NOW

The Community Volunteer Income Tax Program (CVITP) is back for another year, offering eligible residents help filing their personal taxes.

For over 15 years, both the Family and Community Support Services (FCSS) and the Canada Revenue Agency (CRA) have worked together to create a program that assists eligible residents who have a modest income and a simple tax situation. Community volunteers are trained by the Canada Revenue Agency to provide tax assistance and help residents access significant government benefits.

The program runs until the end of April.
