ANIMAL LICENCE NOTICE

September animal licence renewals have not been mailed due to technical issues. We are working with our service provider to diagnose and fix the problem and will mail renewal notices when that happens. In the meantime, eServices will not be able to process September renewals; no penalties will be charged for late renewals.

All businesses located or operating in the Town of Cochrane must hold a current business licence.

This includes non-resident business owners or operators whose premises are located outside of the Town, but who travel (or have their employees travel) to Cochrane to conduct business.

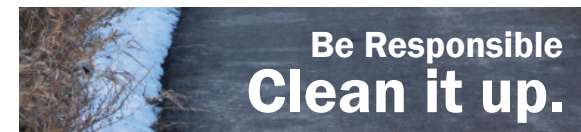

Any person who deems to be affected by the issuance of these permits may appeal to the Subdivision and Development Appeal Board by 4:30 p.m., October 25, 2018. On Permitted Uses, grounds for appeal must relate to questions of interpretation, variance, or relaxation, and not to the proposed use. On Discretionary Uses, all aspects of the proposed development may be challenged upon appeal. Written notice of appeal, accompanied by the appeal fee as established by Town Council, shall be filed through the Office of the Secretary of the Subdivision and Development Appeal Board at 101 RancheHouse Road Cochrane, Alberta T4C 2K8.
