KEEP CATS ON YOUR PROPERTY

Cochrane's Animal Bylaw requires all cats to be kept indoors.

Indoor cats are:

- safer and far from traffic, unfriendly animals, predators, diseases, frostbite, dehydration, poison and abuse from humans
- older: indoor cats live 12 to 15 years; outdoor cats only live 2-5 years
- under your control: not destroying property, urinating, defecating, meowing, howling or running at large in the community

Think Fluffy needs some outdoor time? Build a cat run or take him out on a leash.

Any person who deems to be affected by the issuance of these permits may appeal to the Subdivision and Development Appeal Board by 4:30 p.m., November 15, 2018. On Permitted Uses, grounds for appeal must relate to questions of interpretation, variance, or relaxation, and not to the proposed use. On Discretionary Uses, all aspects of the proposed development may be challenged upon appeal. Written notice of appeal, accompanied by the appeal fee as established by Town Council, shall be filed through the Office of the Secretary of the Subdivision and Development Appeal Board at 101 RancheHouse Road Cochrane, Alberta T4C 2K8.

All businesses located or operating in the Town of Cochrane must hold a current business licence.

This includes non-resident business owners or operators whose premises are located outside of the Town, but who travel (or have their employees travel) to Cochrane to conduct business.
