The Town of Cochrane is responding to FOIP2023-0010 that originally requested:

Access to financial statements/documents for money paid out, relating to any termination of a former employee of the Town of Cochrane between January 1, 2017, and April 17, 2023.

Per your May 12, 2023, email, the search was carried out based on your confirmed definition of "terminated" being "fired" and scope change from "any termination of a former employee of the Town of Cochrane between January 1, 2017, and April 17, 2023" to "only administrative staff, for January 1, 2023 to current."

The Town of Cochrane confirms that a financial statement reflecting staff terminations does not exist but staff reported that \$117,390.46 was paid out for administrative staff terminations for the period requested.
