Centre Avenue - Phase 3 Improvements Borrowing Bylaw – 03/2023

Cochrane Council proposes to pass a borrowing bylaw to finance construction of the Centre Avenue – Phase 3 Improvements project in the amount of \$1,848,960. The borrowing is expected to be repaid over a 20-year timeframe, wholly from off-site levies.

Electors may submit a separate petition with respect to the advertised bylaw calling for a vote of the electors to determine whether the proposed bylaw should be passed.
