

#### Bylaw 24/2023: 365 Railway Street West Land Use Amendment

What is Bylaw 24/2023? This means the land use at 365 Railway Street West (Block G, Plan 1325JK) within the Downtown would change from Industrial Business (I-B) District to Direct Control (DC-02) District.

What does this mean? The amendment would allow for the uses prescribed in the General Commercial (C-G) District with the addition of adding Greenhouse and Garden Centre as a permitted use in a Direct Control District. The purpose of the Direct Control District is to provide for development with unique characteristics, unusual site constraints or innovated design that requires specific considerations that are unavailable under any other land use districts.
