Applicants requesting an "expedited" Development Permit (not applicable to all application types), Compliance Certificate, Encroachment Agreement or any other Planning related application will be assessed a surcharge of 400%.

Any application fee payment or security collected, over the amount of \$3,000.00, paid by credit card will be subject to a 3% service fee.
