#### What is the Heritage Hills Area Structure Plan Amendment?

This amendment is proposing to allow for the addition of Residential Medium Density (R-MD) zoning that was not contemplated in the original Ara Structure Plan. Additional amendments include revisions to the pathway plan, updated development statistics, updated servicing information and updated to the phasing plan.

### What does this mean?

This means that if the amendments to the Area Structure Plan are approved, this would guide proposed amendments also being sought to the Stage 2 Neighbourhood Plan and the Land Use for portions of the Heritage Hills community.
