We are reaching out again with a reminder that you must submit your Campaign Disclosure Statement (Form 26), **along with an itemized expense report**, under the *Local Authorities Election Act (LAEA)*. If you are receiving this email, it is because we have not received any documentation, or the documentation provided is incomplete. Please submit the completed forms by **March 1, 2026**.

Please note that you must file even if:

- You had no campaign contributions or expenses, or
- You withdrew your nomination.

Candidates who do not file their campaign disclosure by the deadline may face:

- A late filing fee
- Public posting of their non-compliance status
- Disqualification from running in future elections until the filing is completed
